Spring Time is here! Let's make this the best Spring and Summer! With this time of year come new projects, beautiful gardens, and much-needed vacations!

#### Just a couple reminders:

- Always check the covenants for our Oakbrook community whenever your home improvement plans include
  construction, landscaping or things like moving a shed or large play equipment onto your property. If it is mentioned in
  our covenants, or in the City of Littleton Codes, it is best to email us on the Oakbrook Covenants address listed below to
  see if committee approval and/or permits are needed. We can quickly give you the guidelines for your project!
- Since it is "camping time," please remember to organize proper storage for your recreational vehicles when not in use. If stored at your residence, they must be on an approved surface, behind a six-foot privacy fence and behind the front setback of the house.
- Finally, a friendly reminder that trash cans should also be stored concealed from view behind front setbacks.

# The Treasury

Please see our website at <a href="www.oakbrookhoa.com/financial-statements/">www.oakbrookhoa.com/financial-statements/</a> for Financial Statements updated as of May 17, 2022. The highlights are:

- We have received \$2,343 in dues and \$531 in legal fee reimbursements, and spent \$1718 for various expenses, for a <u>net income of approximately \$1,157</u> so far this year, which is a combination of some people paying dues "early" before the dues drive, a check reimbursing us for legal fees from last year, and less spending so far this year particularly on our weed spraying and newsletters.
- We have spent about 20% of our budget so far in 2022. Major expenses yet to come include neighborhood maintenance, newsletters, and there is always the possibility for legal fees. We may also hire a lawyer later this year or early next year to update our Declaration (which has not been <u>majorly</u> overhauled since it was written circa 1980) to bring our documents into closer accordance with State Laws passed after 1980.
- Remember, the neighborhood dues fund our operations for the year. <u>Our covenants and the supporting dues benefit</u> every house in the subdivision and keep our home values higher than unprotected neighboring developments, so please do your part and contribute your \$35/year it costs less than a single Starbucks every month!
