This year has been quiet, as far as Homeowner concerns expressed for violations. Home improvement projects are keeping our Board members and Covenant Committee busy with approvals! Homeowners have been meticulous in assuring proper procedures are being followed. This, generally, allows for quick approval. As Vice President of our Oakbrook HOA, and on behalf of Covenant Committee, and HOA Board of Directors, I want to thank you for making our job easier!

At this point, I must say that it seems there are still a few that believe it is ok to leave their trash and/or trash containers stored visible from the street when not in use. This is against the Oakbrook covenants. The trash/garbage containers must be stored behind a security fence or other type of enclosure, or in the garage, assuring they are not visible from the street, or other neighboring lots. We see some stored improperly, with the justification that "other residents" have theirs out, next to the house, in front of the fence or some other such location, so it must be ok for me to do the same! IT IS NOT OK; IT IS STILL AGAINST COVENANTS! Those of us on the HOA Board of Directors, and covenant committee members are volunteers, and most of us work at full time employment, so we may not get courtesy/reminder letters out quickly to those that are in violation. So, we again ask, please take the lead in your neighborhood, and comply with the covenants. In this way, we can all benefit from a more appealing neighborhood, which in turn keeps our home values high!

We want to thank residents with Campers, and other types of trailers for keeping within the rules as far as "storage procedures". Most of you have made every effort to follow the covenants. At this time, we have a camper consistently stored outside the approved covenants guidelines. These residents have been given every opportunity to correct these concerns, with courtesy letter sent.

Because of new regulations governing enforcement, as published in this newsletter, it has taken some time to assure we have the latest procedures in place. To those residents that have expressed concern as to why this year it seems to be taking longer to enforce covenants, please be assured we have not overlooked those that are in violation. Once these procedures are published, we can and will continue to enforce our covenants. We understand, when we accepted the nomination to run for office on the Oakbrook Board of Directors, we also accepted the responsibility to enforce Oakbrook Homeowner Association covenants to the best of our ability.

# Legal Brief

Hello Neighbors,

We hope you are having a wonderful Spring/Summer so far! The Board wanted to take the time to share with you a few updates. In 2022 and now in 2023, there has been a lot of new legislation surrounding HOAs. For instance, an HOA Task Force is to be appointed at the state level to examine issues regarding homeowners' rights and to perform other duties as noted in the new law, which is set to meet starting August 1, 2023. While our HOA doesn't have to comply with a lot of that due to having mandatory covenants but voluntary dues, we felt that some of the legislation would be a benefit to our Association. One of our goals for 2023 is achieving more transparency and improving ways of running the Oakbrook HOA. As such, we have implemented three new policies for Oakbrook HOA, effective immediately. We also plan to continue evaluating and adding new policies as new legislation is passed that is in line with our Association and our neighborhood, one of which is the new Water-Wise Landscaping Requirements of Senate Bill 178.

A short summary of each policy:

#### **Dispute Resolution**

This policy will help to outline a better process for disputes between homeowners and Oakbrook HOA, as well as between neighbors to support in resolving issues prior to them escalating.

#### **Covenant Enforcement**

This policy provides a more transparent way that the Association and the Covenants Committee will enforce any covenant violations, to include notices of alleged violations, the ability to request a hearing, as well as the ability to enforce the covenants and legal actions that the Association is able to take. This is in line with new legislation that passed in August 2022 - HB 22-1137

#### **Records Inspection**

This policy clarifies what records are available upon homeowner request as well as the duration of time that the Association is required to maintain records.
